

LUNENBURG SO MUCH TO LOVE Contest Rules

This contest is exclusively run by the Lunenburg Board of Trade (LBOT) and is in no way sponsored, endorsed, or administered by Facebook or Instagram.

General

1. No purchase is necessary.
2. Contest is open to persons over the age of 19.
3. Multiple entries are allowed but each submission of must include a different participating business
4. Contest is not open to residents of the Province of Quebec.
5. This contest will be open from 12:01am Atlantic on October 1, 2021 until 11:59am Atlantic on October 31, 2021.

Contest Prizes

6. Contest prize is \$2,000 in LBOT dollars to be spent at participating Lunenburg Board of Trade businesses with in 1 year of receipt.
7. The Contest Prize must be accepted as awarded.
8. The Contest Prize will be awarded at the sole discretion of the Lunenburg Board of Trade.
9. The Lunenburg Board of Trade reserves the right to substitute prizes of equal value in the event that the prize described is unavailable due to circumstances beyond their control.
10. The winner will be required to pick up their prize at the Lunenburg Board of Trade offices located at 11 Blockhouse Hill Road, Lunenburg, Nova Scotia.

Winner Selection Process

11. On November 1, 2021 a random draw will be conducted from among all eligible entrants with one winner being declared.
